# PROCLAMATION OF THE MAYOR OF THE CITY OF GIG HARBOR

## Recognizing the Rights and Value of the Southern Resident Orca

**WHEREAS**, the Southern Resident Orcas are culturally and economically important to the people of Washington State and the world; and

**WHEREAS**, despite legal protections for nearly two decades, the population continues to decline and is critically endangered, with only 74 individuals remaining; and

**WHEREAS**, over 20 countries, dozens of local communities in the United States, and several tribal governments have recognized that nature has inherent rights, and that human society has the responsibility to protect and steward nature; and

**WHEREAS**, the rights of the Southern Resident Orcas include, but are not limited to, the right to life, autonomy, free and safe passage, adequate food supply from naturally occurring sources, and freedom from conditions causing physical, emotional, or mental harm, including a habitat degraded by noise, pollution, and contamination; and

**WHEREAS**, major factors in the decline of the Southern Resident Orca population include captures for marine parks in the 1960s and 70s, declining salmon runs, toxic pollution, loss of habitat, and increasing vessel traffic and noise levels in Puget Sound and the ocean; and

**WHEREAS**, bringing attention to the Southern Resident Orcas will also bring attention to the need to clean up Puget Sound and restore and conserve important Puget Sound habitats and Chinook salmon spawning grounds; and


**WHEREAS**, we are fortunate to have this community of Southern Resident Orcas in our midst, know them as individuals and pods, and watch them from our ferries, boats, and many miles of shoreline; and

**WHEREAS**, we have only begun to learn about the intelligence and social capabilities of Southern Resident Orcas; and

**WHEREAS**, Washington State supports efforts to recover this endangered population of Southern Resident Orcas.

**NOW THEREFORE**, I, Tracie Markley, Mayor of the City of Gig Harbor, Washington, do hereby proclaim that the City of Gig Harbor supports and urges action by local, State, federal, and tribal governments that secure and effectuate the rights of the Southern Resident Orcas and of the ecosystems upon which they depend.

However, despite legal protections for nearly two decades, the population continues to decline and is critically endangered, with only 73 individuals left in the wild.

**WHEREAS**, the Orcas’ survival is dependent on healthy and functioning ecosystems including the Salish Sea, the Fraser River Watershed, the Columbia River Basin, and the lower Snake River Watershed.

**WHEREAS**, the rights of marine mammals to exist and flourish have been recognized internationally and locally, including through the Helsinki Declaration (2010), the Marine Life Proclamation of the City of Malibu, California (2014), and the City of San Francisco’s resolution guaranteeing the Free and Safe Passage of Whales and Dolphins in San Francisco’s Coastal Waters (2014).

**WHEREAS**, in May 2018, the Affiliated Tribes of Northwest Indians of the United States, passed a resolution (Resolution #18-32) recognizing Blackfish (referred to by non-indigenous peoples as “Orcas”) as revered relations for which there is a sacred obligation to ensure they are treated “in a dignified manner that reflects tribal cultural values that have been passed down for countless generations.”



*WHEREAS*, the Orcas' survival is dependent on healthy and functioning ecosystems including the Salish Sea, the Fraser River Watershed, the Columbia River Basin, and the lower Snake River Watershed; and

*WHEREAS*, over 20 countries, dozens of local communities in the United States, and several Tribal governments have recognized that nature has inherent rights, and that human society has the responsibility to protect and steward Nature in a manner consistent with our interconnected relationship; and

*WHEREAS*, Nature and all living beings, including the Southern Resident Orcas and the ecosystems upon which they depend, are recognized as possessing inherent rights, including the right to exist, flourish, evolve, regenerate, recover, and be restored; and

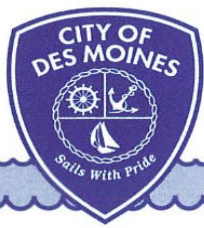



**Resolution No. R2023-30**

**A Resolution of the Pierce County Council Recognizing the Inherent Rights of the Southern Resident Orcas in Pierce County, Washington.**

**Whereas**, the Southern Resident Orcas (Orcas) are culturally, spiritually, and economically important to the people of Washington State and the world and have been a sacred, spiritual species to the Tribes of Pierce County since time immemorial; and

**Whereas**, in May 2018, the Affiliated Tribes of Northwest Indians of the United States passed a resolution (Resolution #18-32) recognizing the Orcas as revered relations for which there is a sacred obligation to ensure they are treated "in a dignified manner that reflects tribal cultural values that have been passed down for countless generations"; and

**Whereas**, the community of Southern Resident Orcas were listed as an endangered species in November 2005, but despite legal protections for nearly two decades, Orca populations continue to decline and are critically endangered, with just over 70 Orcas left in the wild; and

**Whereas**, the Orcas' survival is dependent on healthy and functioning ecosystems, and the remedy of identified major factors in the decline of Orcas including declining salmon habitat and runs, increased competition for prey, toxic pollution, climate change, population growth, increasing vessel traffic, and noise; and

**Whereas**, through collaborative work with the Puyallup Tribe of Indians, the Muckleshoot Indian Tribe, the Nisqually Indian Tribe, the Squaxin Island Tribe, Salmon Recovery Lead Entities, local Watershed Councils, and other federal, state, and local partners, Pierce County is working to implement policies and programs that promote Orca recovery through efforts to address impacts to critical areas, remove fish passage barriers, treat and reduce stormwater impacts prior to entering South Puget Sound, implement a salmon habitat restoration and protection program, plan for climate resilience, prevent human waste pollution through a mobile pump-out boat program, and more; and

**Whereas**, over 20 countries, dozens of local communities in the United States, and several tribal governments have recognized that nature has inherent rights, and that human society has the responsibility to protect and steward nature in a manner consistent with our interconnected relationship; and

**Whereas**, nature and all living beings, including the Orcas and the ecosystems upon which they depend, are recognized as possessing inherent rights, including the right to exist, flourish, evolve, regenerate, recover, and be restored; and

**Whereas**, the rights of the Orcas include, but are not limited to, the right to life, autonomy, culture, free and safe passage, adequate food supply from naturally occurring sources, and freedom from conditions causing physical, emotional, or mental harm, including a habitat degraded by noise, pollution, and contamination; **Now, Therefore,**

**BE IT PROCLAIMED** by the Pierce County Council that the Southern Resident Orcas have these inherent rights, and urge action by local, state, federal, and tribal governments that secure and effectuate the rights of the Southern Resident Orcas and of the ecosystems upon which they depend.
